Call to Order and Pledge of Allegiance

Chairman Blair called the meeting of the Ohio Lottery Commission to order at 12:01 p.m.

Chairman Blair moved to approve the nineteen (19) Administrative Rules in Final Form with Commissioner Gupta offering a second to the Motion. The Motion was affirmatively voted upon by the Commissioners present.

Resolution to Approve thirty-four (34) new Video Lottery Terminal (VLT) Game Themes

Charles LoPresti, Chief Legal Counsel, presented a Resolution to approve thirty-four (34) VLT game themes.

Chairman Blair moved to approve the Resolution with thirty-four (34) VLT game themes with Commissioner Brady offering a second to the Motion and the Motion was approved by all Commissioners present.

Office of Finance Report

Traci Pinkney-Nichols, Finance Manager, provided the financial update on behalf of Chief Fiscal Officer Slyman. The total traditional lottery games sales for the month of May were \$367.4 million, higher than in May 2023, which is a 3.2% increase and equals \$11.3 million. Draw-based game sales for May were \$163.6 million, up 3.9% over the same month last year, or \$6.1 million.

Ms. Pinkney-Nichols reported that daily draw game category sales were \$62.7 million, up \$1.5 million or 2.4% over last year. Additionally, Ms. Pinkney-Nichols stated that multi-state games generated sales of \$24.3 million, an increase of \$4.5 million, or 23% over last year. Keno and Lucky One sales were \$55.0 million, down \$1.4 million, or -2.5% compared to last year. EZ play family of games generated sales of \$14.7 million, up \$1 million, or 7.4% compared to last year. Scratch-Off ticket sales for the month of May were \$203.8 million, or 2.6% higher than last year. Ms. Pinkney-Nichols stated that for the past 10 weeks the \$5, \$10, \$20 and \$50 product lines surpassed sales compared to last year and expects the positive sales trend to continue.

Ms. Pinkney-Nichols reported that Gross Gaming Revenue from VLTs equaled \$119.8 million, which was up \$4.5 million, or 3.9% compared to last May. Lastly, Ms. Pinkney-Nichols reported that total prize expense for May was \$243.9 million, which is 66.4% of sales.

Director's Update

Director Gillcrist reported that the Lottery's transfer to the Lottery Profit's Education Fund (LPEF) for the month of May \$128.9 million. This is \$8.7 million more than our LPEF commitment and \$6.4 million more than last year. Ms. Gillcrist reported that Year-to-date Lottery profits are up \$89 million over our commitment and \$47.9 million more than last year. Therefore, the Lottery has transferred \$1.43 billion, officially meeting the FY'24 commitment in the month of May and still have the month of June left in the fiscal year. Director Gillcrist and the Commissioners thanked all the Lottery employees for all their hard work.

Director Gillcrist reported that we recently applied for our renewal of the Responsible Gambling Verification from the National Council of Problem Gambling (NCPG) and North American Association of State and Provincial Lotteries (NASPL). Director Gillcrist was pleased to report that the Responsible Gambling Program was certified by both entities as having "Exceeded Standards" at the "Sustaining Level". Director Gillcrist noted that the NCPG Executive Director Keith Whyte noted that "In order to achieve this rating, the application must meet standards in all eight of the categories evaluated by the assessors. In addition, assessors must agree that the lottery exceeds standards in four of the eight categories. This is a very difficult threshold to achieve, as Ohio remains the only lottery to merit an "exceeds standards" rating at any level, let alone at the sustaining level."

The certification is good through May of 2027, and underscores our commitment to promoting responsible gambling practices. Director Gillcrist thanked Deputy Director of Responsible Gambling, Jimmie Hicks and RG Program Manager, Susan Diamond, for all their hard work as they continue to grow our program.

Lastly, Director Gillcrist invited Deputy Director of Marketing, Tom Ackerman, to give a recap of the recent 50th Anniversary promotion and a sneak peek into the fall's 50th Anniversary celebration.
